



Criminal Code Contents With Linked Section Numbers

The following is a table of contents for the Criminal Code as of November 24, 2009, the purpose of which is to enable you to obtain the URL of any section within a freely available online version of the Code, something that is not easily done otherwise. The links are to parts and to sections within the English version of the Code as it is presented on the federal Department of Justice website. I have modified the hyperlinks to make the URLs as lean as possible. Not all sections are linked here.

To construct a hyperlink to a section that is not explicitly given below take any link to a section within the same part of the code and substitute the desired section number for the one in the URL selected. Thus, for example, in PART XI, s.437 is shown and linked, but s.438 is not; the URL for s.437 is
