## **Free Income Tax Clinics**

Our volunteer-run program is intended to help you with straightforward tax returns. Our volunteers are not trained to prepare returns for deceased or bankrupt individuals, individuals who have capital gains or losses, self employed, businesses, or those with rental property income or expenses.

#### Eligibility:

- if you are MARRIED/COMMON-LAW and your combined income is less than \$30,000
- if you are SINGLE and your income is less than
- if you are a SINGLE PARENT with a child and your income is less than \$30,000 (for each ADDITIONAL DEPENDENT add an additional \$2,000)

If you wish to have your return prepared by one of our volunteers, please bring required information to your appointment to ensure that a volunteer can complete the return. (See next column)
